

**IronFX IB Qualification Promotion
Terms and Conditions**

1. IronFX promotes the IronFX IB Qualification Promotion (“IB Promotion”).
2. For participating in the IB Promotion, you have to complete registration for an IB account providing the details requested (first and last name, telephone, email and country) and be over 18 years old. All details provided during the registration process should be correct (i.e. full name details to match the proof of identity, proof of residence to match the country of residence, etc.) otherwise the participants/winners will be disqualified from the IB Promotion.
3. The IB Promotion is available to new or existing registered and approved Introducing Brokers (“IBs”)¹ which are based in India. The IB Promotion is not available to IronFX employees and other Partners.
4. By participating in the IB Promotion, you acknowledge that you have read and agreed to be bound by these Terms and Conditions as well as to the IronFX Trading Terms of Business.

2	USD 25,000	25 Lots	A Smartphone OR USD 2,000 Cash Prize
3	USD 10,000	10 Lots	A Tablet OR USD 750 Cash Prize

**Note: The minimum traded lots include FX, Commodities and Metals.*

*** Note: The Tablet, Smartphone and Laptop values will be up to the equivalent of the respective cash prize.*

7. The IB promotion winners will be determined as per the below factor(s)

Net MI: Deposits – Withdrawals

- The winners will be the 3 IBs with the highest total qualifying Net MI **and** minimum traded lots in the respective performance category on the closing of the market on 15 October 2021.
- Deposits stands for the total amount deposited under the IB during the IB promotion period, and includes Local Agent deposits made under the IB.
